1) Required documentation for breeding

- Copy of current negative brucellosis test(natural breeding only)
- Copy of pedigree and picture of bitch
- Copy of OFA Hips and Elbows certification and CERF

- Progesterone testing: Before a natural breeding will be attempted, a current progesterone test that shows a progesterone level higher than a 5.0 will be required. Breeding should then occur 24-48 hours after the level is above a 5.0

**Natural Breeding- Stud Fee \$1000** a deposit of \$300 is required at or before time of breeding paid to Dairyland Retrievers. If natural breeding is to be done at Baker Retrievers an additional fee of \$75 will be due at time breeding, to be paid to Baker Retrievers.

**Side by Side – Stud Fee \$1000** a deposit of \$300 is required at or before time of breeding paid to Dairyland Retrievers. If Baker Retrievers is needed to transport SWAT to a vet clinic for the side by side to be performed an additional fee of Baker Retrievers discretion will be due at the time of breeding paid directly to Baker Retrievers. Any and All vet expenses are the responsibility of the Bitch owner(s).

**Frozen Semen- Stud Fee \$1000** a deposit of \$300 is required before semen will be used/shipped. 1(one) “breeding unit” will be released per breeding. If more then 1(one) breeding unit is requested the full stud fee will be required per breeding unit before the semen is released. All shipping and vet expenses associated with the frozen semen transport, paperwork and implantation of semen is the responsibility of the bitch owner(s)

All forms of breeding are guaranteed to result in a pregnancy. If no pregnancy is achieved a second breeding attempt will be provided with no additional deposit required on the same bitch as the original breeding. No refund will be given for vet and shipping costs or costs of Baker Retrievers help.

All forms of breeding a full litter is considered 3 live pups. If less than 3 live pups are whelped stud fee equals \$300 per pup.

Mating of dogs can be dangerous and lead to injury. The female’s owner shall indemnify and hold harmless, Kyle and Megan Hensen and any other officer, agent, or employee from all suits, actions, losses, damages, claims, or liability of any character, type, or description, foregoing all expenses of litigation, court costs, and attorney's fees for injury or death to any person or dog, or injury to any property, received or sustained by any person, animal or property, arising out of the acts completed in execution of this contract or occasioned as a result of this agreement.
